#### **SPECIAL PRESENTATIONS:**

#### Bruce Arndt, VVA Chapter 1106 Member – Veterans Court

Courts along the Front Range have a Veterans Court program. First the Veteran must plead GUILTY and then work to follow a program to be eligible for "expunge" crime from one's record.

- --Offenses include almost any crime, but not guns, murder, sexual crimes, or bank crimes. Many are drug related crimes.
- --The court can provide food / shelter as needed. Social Worker and Mentor Volunteers are assigned to monitor the Veteran's progress. Veteran must appear in court ever two weeks to account for efforts—attended counseling, drug testing, etc.
- --VVA 1106 member -Dr. Bob Mallin—is a Volunteer Mentor for Veteran Court.
- --This 2-year-old court program has a 2% recidivism rate.
- --22 Veterans are currently in Denver Veteran Court program, with a future cap of 60.

Hospital, and we provided him with a Power Chair that was donated to us, a transport chair and funds for two ramps up to his house for a total of \$1,100.00. We provided funds toward rent for a Veteran for \$230 and two gift cards totaling \$250.00 for two other Veterans.

  - -Warren Harrison, Donna Chaney and Pattie Ehline are on a VA Mental Health Advisory Committee at the VA Hospital. Let them know your plaudits and concerns for VA Mental Health Care.
  - -A Voice for Veterans meeting will be occurring at the VA Hospital on May 2, and you are invited to attend.
  - -Pattie was recently a surgery patient at the new VA hospital, and she says she, as a Nurse, was "truly impressed" with the quality of care she received.

- 4. Scholarship Committee Co-Chairs Mike Karsh and Jim Marcille; John Vargas, Glen Payne. Committee has visited all the high schools to leave to posters for their wall and insure students can see our scholarship data is in the HS computer database.
